

Sunmark Credit Union | Car Loan Promotion Giveaway Official Rules

NO PURCHASE, DONATION, OR PAYMENT OF ANY KIND IS NECESSARY TO WIN.

Purchase/donation will not improve chances of winning. Odds of winning are determined by the number of eligible entries received and winners will be chosen at random. The Sunmark "Car Loan Promotion Giveaway" ("the Sweepstakes") is sponsored by Sunmark Credit Union ("Sunmark"). This Sweepstakes is governed by these Official Rules ("Official Rules"). Sunmark shall be entitled to interpret these Official Rules as needed – including but not limited to rules regarding entries, deadlines, winner selection, prize restrictions, and eligibility – and all its decisions are final. By participating in the Sweepstakes, you agree to abide by all these Official Rules and waive any right to claim ambiguity in these Official Rules or any other Sweepstakes-related advertising or materials. The Sweepstakes is subject to all federal, state and local laws and regulations and is void where prohibited by law.

1. Eligibility. The Sunmark Car Loan Promotion Giveaway IS OPEN ONLY TO LEGAL U.S. RESIDENTS WHO ARE AT LEAST AGE 18 (OR THE AGE OF MAJORITY UNDER APPLICABLE LAW). IF YOU DO NOT MEET THESE ELIGIBILITY REQUIREMENTS, OR ANY OTHER REQUIREMENTS IN THESE OFFICIAL RULES AS OF ENTRY DATE, YOU ARE NOT ELIGIBLE TO PARTICIPATE OR WIN A PRIZE. In addition, entrants must have Internet access, a valid e-mail account and phone number prior to entry. To be eligible to win a prize, entries must be completed and received by SUNMARK in the manner and format designated below. Employees, immediate family members, Board of Directors and volunteers of Sunmark, and the members of their immediate families (defined as spouse, parents, siblings or children) and households (defined as all persons residing together in a single residence, whether or not related) are not eligible to enter or win any prizes.

2. Contest Period. The Sweepstakes consists of two (2) weekly entry periods:

- Week 1 begins March 25, 2026 at 12:00 AM Eastern Standard Time ("EST") and ends March 29, 2026 at 11:59 PM EST.
- Week 2 begins March 30, 2026 at 12:00 AM EST and ends April 3, 2026 at 11:59 PM EST.

Sunmark CU's computer is the official time-keeping device for the Sweepstakes. Sunmark reserves the right to shorten or extend the Sweepstakes at their sole discretion.

3. How to Enter. To enter, participants must complete BOTH of the following steps during the applicable weekly entry period:

- A) Follow the official Sunmark Credit Union page on Facebook or Instagram; AND
- B) Comment on the official Sunmark Car Loan Promotion Giveaway post on Facebook or Instagram.

Alternatively, you may mail a postcard with your full name, address, email address, and phone number to: Sunmark Credit Union "Car Loan Promotion Giveaway," 1187 Troy Schenectady Road, Latham, NY 12110. Mail-in entries must be postmarked by 11:59 PM EST on the last day of the applicable weekly entry period and received within five (5) days thereafter to be eligible for that week's drawing.

Only one (1) entry per person, per week, per platform is permitted. Entries submitted on both Facebook and Instagram during the same week will be counted as separate entries. Mail-in entries count as one (1) entry per week regardless of the number of postcards submitted.

4. Prizes. A total of ten (10) prizes will be awarded across two (2) weekly prize periods, with an approximate total retail value of nine hundred dollars (\$900.00).

Week 1 Prizes (awarded at the conclusion of Week 1):

- One (1) grand prize consisting of one (1) detailing kit valued at approximately two hundred dollars (\$200.00) and one (1) Stewart's gas card valued at fifty dollars (\$50.00); approximate combined value: \$250.00.
- Four (4) prizes, each consisting of one (1) Stewart's gas card valued at fifty dollars (\$50.00) each; approximate value per prize: \$50.00.

Week 2 Prizes (awarded at the conclusion of Week 2):

- One (1) grand prize consisting of one (1) roadside assistance kit valued at approximately two hundred dollars (\$200.00) and one (1) Stewart's gas card valued at fifty dollars (\$50.00); approximate combined value: \$250.00.
- Four (4) prizes, each consisting of one (1) Stewart's gas card valued at fifty dollars (\$50.00) each; approximate value per prize: \$50.00.

All prizes are awarded "as is" with no warranty or guarantee, either express or implied, by the Sponsor. Prizes are non-transferable, non-assignable, non-exchangeable, and may not be redeemed for cash. No substitutions will be made, except that the Sponsor reserves the right, in its sole discretion, to substitute a prize of equal or greater value if the stated prize becomes unavailable. Gift cards are subject to the terms and conditions of the issuing merchant, and the Sponsor is not responsible for lost, stolen, or expired items, or for any issues related to redemption.

5. Selection and Notification of Winners. Five (5) winners will be selected at random at the close of each weekly entry period. Winners will be notified by direct message via the platform (Facebook or Instagram) through which their winning entry was submitted, within five (5) business days following the close of each weekly entry period. If the winning entry was submitted via postcard, notification will be made via the email address provided on the winning entry. To claim a prize, the winner(s) must follow the instructions contained in the notification message. Winners may be issued an IRS 1099 MISC tax form (or its equivalent) for the actual prize value awarded if required by law.
